# BOARD OF DIRECTORS ELECTION PROCEDURES

- 1. The Election Committee is established by the Board of Directors, which is charged with the responsibility of conducting all such elections subject to approval by the Board of Directors. The Election Committee shall be comprised of two or more Directors or Director Emeritus of this Corporation.
- 2. Each candidate for election shall designate a representative who will have the right to examine all documents in connection with the election, observe the election, and attend all meetings of Election Committee.
- 3. On the morning of the first full day of the Annual Conference each candidate, shall be afforded the opportunity to address the general membership; in alphabetical order by candidate last name for no longer than 3 minutes. If there is no election to be had for a particular year, an announcement will be made by a member of the Election Committee at the General Membership meeting at the Annual Conference.
- 4. The election shall commence immediately following the opening ceremonies on the first full day through noon the second day of the Annual Conference. Ballot packages will be available at the Election Committee table in the Exhibitors Hall and must be signed for by a verified trustee.
- 5. Ballot totals shall be counted, verified and signed by each member of the Election Committee and candidate representative in a manner and location that is open for viewing by the general membership.
- 6. The results of the election shall be posted, in the registration area of the Annual Conference and reported to the Board of Directors at a regular meeting.
- 7. Elected Directors shall be seated by the Board of Directors at a regular meeting during the Annual Conference.
- 8. The Secretary of the Board of Directors of the FPPTA shall take charge of the ballots and hold in a safe place for 30 days. After 30 days the ballots shall be destroyed.
- 9. In the event of a Tie Ballot, a run-off election shall be conducted by the Election Committee on the morning of the final day of the Annual Conference.
- 10. Challenges to election results shall be considered by the Board of Trustees at a regular meeting during the Annual Conference.
